APPLICATION FOR WATER AND SEWER SERVICE**

TO THE CITY OF MARQUETTE HEIGHTS:

I hereby make application for water and sewer service, to be supplied at the address shown below and TO CONTINUE UNTIL SERVICE IS TERMINATED BY MY WRITTEN NOTICE TO THE CITY OR AS HEREIN PROVIDED. No changes will be made in the service or fixtures supplying the premises shown below without my first notifying, in writing, the City of Marquette Heights.

I agree to abide by the established rules and regulations of the City of Marquette Heights now in force, or which may hereafter be enacted or adopted for the operation of said company. I further agree to pay said bills for services rendered thereof in accordance with the water and sewer rate, and the rules and regulations of the City of Marquette Heights in effect at the time of delivery or as later filed.

I understand that if bills for water and sewer services become delinquent, the supply of water and sewer services may be discontinued by the City after the written notification has been given to the customer of the City's intention to do so. When necessary to discontinue water and sewer services to any premise because of a violation of the City's rules and regulations or because of nonpayment of any bill, I understand that a charge established by the City Ordinance will be made to cover part of the expense of turning on the water and sewer service, and this charge, together with any arrears that may be due the City for charges against the customer must be paid before the water supply and the sewer service will be resumed. I understand that the City's rules and regulations and conditions applying to water and sewer services are on file at the city Office and are available for my information.

I agree to pay for any and all cost, charges and fees related to the collection and/or litigation of delinquent bills. The collection process will be instituted when any charges for water and sewer services become 90 days past due. All cost, charges and fees will include, but not be limited to, attorney fees, collections fees and court costs.

I agree to make a DEPOSIT simultaneously WITH THE SIGNING OF THIS AGREEMENT TO GUARANTEE PAYMENT OF BILLS FOR SERVICES RENDERED. Refunds will be given according to the following policies: Homeowners will have the deposit returned automatically after ten (10) non-delinquent payments are made within twelve (12) months. Renters will have the deposit refunded only upon termination of service.

I further understand that the foregoing constitutes an agreement for value received between myself, my heirs, executors and administrators, and assigns the City its successor. If an owner, I agree to give prompt notice of any sale or lease of this property to the City Clerk.
